No Slowing Down for Elevate Internet Fiber Build

Since the launch of Elevate in 2016, the phrase “keeping the lights on” has evolved. Not only do we maintain reliable electricity across our distribution lines to keep your lights shining bright, but we also now sustain actual lightwaves within our fiber-optic cables to deliver

high-speed internet. We are only mid-way through 2023, and it has been a construction-intensive year for our fiber internet subsidiary. Since January, our construction crews have built 143 new miles of fiber, bringing our reliable, ultra-high-speed internet to some of the most rural corners of DMEA’s service territory. Work started early in the year with two massive projects funded by federal and state grants. Our Greater Gunnison Gorge Grant project includes 232 miles of fiber in rural Montrose County, including the mountainous terrain near Cimarron. Our Reconnect 2 Grant project includes 272 miles of fiber in rural Delta County, including the Pea Green area.

We have hit the halfway mark in our Greater Gunnison Gorge project. Since January, 798 new homes and businesses now have access to Elevate’s gigabit-speed internet in areas like Shavano Valley and Davewood Road. We anticipate construction on the remaining Greater Gunnison Gorge areas to conclude by the end of the year, with the exception of the Cimarron area. This rugged country presents additional challenges, including weather, terrain, and government agency seasonal access limitations.

For our members in Reconnect 2, I’m happy to announce that Elevate became available last month in the first phase, southeast of Delta. As construction

progresses over the next year, we will steadily connect another 2,239 members west and southwest of Delta.

But there’s more! Just last month, DMEA was awarded yet another grant from the State of Colorado Broadband Board. We received \$1.5M to help build our fiber optic network along Cimarron Road leading toward Silver Jack Reservoir. We hope to begin building here in early 2024, meaning another 109 of our most rural members will have access to Elevate!

What’s left in our construction pipeline? In addition to Greater Gunnison Gorge, Reconnect 2, and South Cimarron, Elevate has two additional grant projects slated to begin next year: East Mesa, located primarily east of Olathe, and Reconnect 3, located in the North Fork Valley. The following two to three years will be a massive undertaking as we construct all the projects listed above, but when complete, more than 95% of DMEA members will have access to the fastest internet speeds in the nation.

And we’re not stopping there – we will continue working to secure additional funds for our remaining members and are creating a plan to reach all of you in the coming years. Thank you for your continued patience and support.

THE IRS SCAM

There are too many scams involving impersonating the IRS to count. Seriously, don't believe us; just check this link out:

One of the most common schemes out there involves criminals calling and posing as IRS agents or using pre-recorded calls "from the IRS" stating there is an issue with your tax return. The IRS won't call you. Period. Hang up and report the scam to the IRS via email to statealert@taxadmin.org.

Prevent WILDFIRES

Even after a wet winter, fire season is still upon us. Wildfires can be devastating, claiming property, homes, and lives. Follow these tips to prevent wildfires this summer:



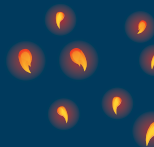
CARE FOR CAMPFIRES

Check fire restrictions and build campfires only in designated areas. Extinguish fires completely before leaving using a shovel and dirt until no smoke is coming from the ashes.



DON'T FLICK YOUR BUTTS

Never throw cigarettes out of car windows or discard them outdoors. Make sure they are extinguished completely before disposing of them in a safe designated container.



WATCH FOR SPARKS

When using outdoor equipment, sparks from lawnmowers, chainsaws, and power tools can ignite dry grass, causing a wildfire. Keep an eye out and don't use on days that are dry and hot.



FREE OF DEBRIS

Clear dry leaves, twigs, and branches from your property, especially around your house. If you burn debris, pick a day without wind and keep a shovel, water, and fire retardant nearby to keep it in check.



PLAN & PREPARE

Create an emergency evacuation plan and designated meeting spot with your family. Prepare a 'Go Bag' that includes essential items such as food, water, and medical supplies.
